



## Giro 2026 Formula 1 Grand Prix Tickets Promotion

### PROMOTION RULES

The Giro 2026 Formula 1 Grand Prix Du Canada Tickets Promotion (the “Promotion”) is sponsored by Villa Charities and Villa Charities Foundation (the “Sponsor”). To enter individuals are required to make an online donation of \$100 CDN to the [2026 Villa Charities Giro event](#) or (b) write and email a 5,000-word essay on the influence of Italian culture on Canadian lifestyle and trends to [giro@villacharities.com](mailto:giro@villacharities.com) (the “Contest Email”). All entries must be received by 11:59 p.m. EDT on May 17, 2026. Void in Quebec and where prohibited by law.

### 1. PROMOTIONAL PERIOD

For the Formula 1 Grand Prix Tickets promotion: The promotional period for the Formula 1 Grand Prix Tickets Draw starts at 12:01 a.m. EDT on **Wednesday, May 6, 2026**, and ends at 11:59 p.m. EDT on **May 17, 2026** (the “**Formula 1 Tickets Promotional Period**”).

### 2. ELIGIBILITY

To enter you must be a legal resident of Canada who has reached the age of majority in your province and make an online donation of \$100 CDN or greater to the [2026 Villa Charities Giro event](#). The following individuals are not eligible to enter the Promotion: Villa Charities Staff or their immediate family members; or residents of the Province of Quebec.

### 3. HOW TO ENTER

Make an online donation of \$100 CDN or greater to the [2026 Villa Charities Giro event](#) during the Formula 1 Tickets Promotional Period to be eligible for the draw for the Formula 1 Tickets Prize. Alternatively, to enter the draw to win the Formula 1 Tickets Prize on a no-purchase basis, an individual can write and email a 5,000-word essay on the influence of Italian culture on Canadian lifestyle and trends to the Contest Email and include their contact information including their phone number. All entries must be received by 11:59 p.m. EDT on May 17, 2026, to be eligible.

### 4. THE PRIZE

Formula 1 Tickets Prize:

- a. The Prize includes: two (2) tickets to attend the Formula 1 Grand Prix Du Canada in Montreal at circuit Gilles-Villeneuve on May 22 – 24, 2026 (3-day pass). The Formula 1 tickets will be located in Grandstand 15. The approximate retail value of the Formula 1 Prize is \$1,750 CDN (one thousand, seven hundred and fifty Canadian dollars).



- b. The Formula 1 Prize must be accepted as awarded. The Sponsor accepts no responsibility for any costs associated with the Formula 1 Prize that are not expressly included in the Formula 1 Prize. In particular, the Winner is responsible for arranging and paying for his/her own transportation to and from the event, accommodations, and meals.
- c. The Formula 1 Prize is non-exchangeable, non-transferable, and is not redeemable for cash or any other prize. The Winner is required to correctly answer a mathematical skill testing question before being awarded the Formula 1 Prize.
- d. The Winner agrees to provide Villa Charities with any personal information necessary to book the Formula 1 Prize in the names of the attendees. This includes but is not limited to: full name, and email address. Once the Formula 1 Prize is booked any costs resulting from changes to ticket information will be incurred at the cost of the Winner.
- e. Villa Charities will pay ticket taxes, fees, and surcharges imposed by the provider and government authority but will not cover any other related costs. The costs that Villa Charities will not cover include but are not limited to: accommodation, transportation, meals or upgrades.

## 5. ODDS OF WINNING

The odds of winning the Formula 1 Prize depend upon the number of eligible entries received during the Formula 1 Prize Promotional Period.

## 6. DATES

The Formula 1 Prize Draw will take place on **May 18, 2026**, at 901 Lawrence Avenue West, Toronto, Ontario M6A 1C3. The Winner will be notified by phone and email within one (1) day of the draw date. If the winner cannot be contacted, Villa Charities reserves the right to select another Winner. The Winner must contact Villa Charities Foundation to receive the Formula 1 Prize by **May 20, 2026**.

- a. Villa Charities and its affiliates accept no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered by you as a result of entering the Promotion or accepting the Formula 1 Prize.
